

1 Euro House Selection Privacy Policy FINAL ENSUPPLEMENTARY PRIVACY POLICY

1 EURO HOUSE SELECTION

Last Updated: 18 January 2021

This Supplementary Privacy Policy for the 1 Euro House Selection (“Supplementary Privacy Policy”) describes how we collect, use, process and disclose your personal data, submitted and collected via www.airbnb.com/1eurohouse (“Site”) and otherwise provided by you as part of your Application to the 1 Euro House Selection (“Selection”). It supplements the Airbnb [Privacy Policy](#), which also applies to your use of and visits to the Site. If we make translations of this Supplementary Privacy Policy available, the English version shall prevail in the event of any inconsistency.

Please read the terms of the Airbnb [Privacy Policy](#) carefully.

Any capitalised terms not defined in this Supplementary Privacy Policy have the same definition as given in the Selection Terms available on the Site, Airbnb [Privacy Policy](#), and Airbnb [Terms of Service](#).

1. INFORMATION WE COLLECT

We collect the information you submit in your Application form and associated materials, as well as the information that you provide to us during any follow-up stages in the Selection process (e.g. screenings, interviews, additional materials requests). Processing of this information is required for you to participate in the Selection and is necessary for the adequate performance of our obligations under the Selection Terms.

When you use the Site, we automatically collect information, including personal data about the services you use and how you use them. Further information is available in the Airbnb [Privacy Policy](#).

2. HOW WE USE INFORMATION WE COLLECT

We will use the information we collect for the adequate performance of the contract between you and us (i.e. the Selection Terms).

If you are selected as the Participant in the Program, we may use and process your personal data to communicate with you regarding the Program, Selection follow-ups, and future promotional or marketing activities. This information will be processed on the basis of our legitimate interest in notifying and announcing the Participant in the Program and to maintain our relationship with you. Note that you can always opt-out of marketing communications by unsubscribe link included in our emails or by contacting us at opt-out@airbnb.com.

3. SHARING & DISCLOSURE

We share and disclose information, including your Application and related personal data, with members of the Judging Panel to enable them to fulfil their roles in the Selection process as well as with third party service providers as described below.

We may use third party service providers to help us with the Selection process. These providers have limited access to your personal data, as required to perform tasks on our behalf, and are contractually bound to protect it and use it only for the purposes for which it was disclosed to them and in accordance with applicable privacy law.

Our service providers may be located inside or outside of the European Economic Area (“EEA”). Laws in these countries may differ from the laws applicable to your Country/Region of Residence. For example, personal data collected within the EEA may need to be transferred, stored, and processed outside of the EEA for the purposes described in this Supplementary Privacy Policy. You agree to such transfer of your data. Where we transfer, store, and process your personal data outside of the EEA we have ensured that appropriate safeguards are in place to ensure an adequate level of data protection. We will provide further information on the means used to ensure an adequate level of data protection upon request. 4. YOUR RIGHTS

You may exercise any of the rights described in this section pursuant to applicable law in respect of your Application, by sending an email to 1eurohouse@airbnb.com with the subject line “1eurohouse@airbnb.com privacy request” in the subject line.

Data Retention and Erasure

We will retain your personal data, except for your contact information, during the Selection process and for post-Selection communications, in accordance with applicable laws. Unless you are selected as a Participant or a Reserve, we will delete any personal data about you promptly after the closing of the Selection, subject to any delay. If you no longer want us to process your personal data, you can request that we erase it by sending us an email explicitly indicating this request.

Please note that if you request the erasure of your personal data:

- you will not be eligible to participate in the Selection;
- we may retain and use your personal data to the extent necessary to comply with applicable legal obligations; and
- in order to maintain the Site and secure it against accidental or malicious loss and destruction, residual copies of your personal data submitted as part of the Application may not be removed from our backup systems for a limited period of time.

If you disagree with the revised Supplementary Privacy Policy, you can cancel your Account. If you do not withdraw your Application before the date the revised Supplementary Privacy Policy becomes effective, your continued access to or use of the Airbnb Platform will be subject to the revised Supplementary Privacy Policy.
