

## SUPPLEMENTARY PRIVACY POLICY FOR CONTESTS

Last Updated: 3 August 2022

This Supplementary Privacy Policy for Contests (“**Supplementary Privacy Policy**”) describes how we collect, use, process and disclose your personal information, submitted and collected via <https://www.airbnb.com/flyandliveanywhere> (“**Site**”) and otherwise provided by you as part of your Entry to the Airbnb Fly & Live Anywhere (in the Philippines) Contest (“**Contest**”). It supplements the Airbnb [Privacy Policy](#) which also applies to your use of and visits to the Site.

### **Data Controller:**

The Airbnb entity that is the data controller of your personal information is Airbnb Ireland Unlimited Company, with address at 8 Hanover Quay, Dublin 2, Ireland (“**Airbnb**”).

Where Airbnb is processing your personal information based on a legitimate interest, you can request that Airbnb does not process your personal information by providing reasons specific to your circumstances. If you object to such processing, Airbnb will review your objection and will no longer process your personal information for these purposes unless we have compelling legitimate grounds for such processing, or otherwise where such processing is required for the establishment, exercise, or defence of legal claims. We will let you know the outcome of our review. You may exercise your rights to object to such processing by sending us an email.

Any capitalised terms not defined in this Supplementary Privacy Policy have the same definition as given in the Official Rules available on the Site, Airbnb [Privacy Policy](#) and Airbnb [Terms of Service](#).

If we make translations of this Supplementary Privacy Policy available, the English version shall prevail in the event of any inconsistency.

### **1. INFORMATION WE COLLECT**

We collect the personal information you submit in your Entry to the Contest (such as your name, age range and contact details) as well as the information that you provide to us during any follow-up stages in the Contest process (e.g. short-list phone interview for the potential Reserves and/or Winner) and from the Winner, details of the Companions.

When you use the Site, we automatically collect information, including personal information about the services you use and how you use them. Further information is available in the Airbnb [Privacy Policy](#).

### **2. HOW WE USE INFORMATION WE COLLECT**

We process personal information for the purposes set out in the Airbnb [Privacy Policy](#) in line with the lawful bases set out. In addition, we process personal information for purposes related to the Contest as follows:

#### **Consent:**

We process your personal information for the activities and purposes outlined in the table below, when you have given your consent to the processing activities.

#### **Legitimate Interests:**

We process your personal information for the activities and purposes outlined in the table below, on the basis of Airbnb’s legitimate interests and the interests of those connected with the Airbnb platform:

<b>Background/verification checks</b> - To the extent permitted by applicable law, If You are shortlisted, Airbnb may perform, at Airbnb’s sole discretion, background and/or verification checks on the information You have provided in order to ascertain or confirm your eligibility to participate in the Contest and, if applicable, to redeem the Prize. **Contractual Necessity:**

We process your personal data for the activities and purposes outlined in the table below, which give effect to the Official Rules of the Contest.

<b>Award of Prize:</b> - If you are the Winner, we will process your details in order to award you the AirAsia travel credits and Airbnb credits which constitute the prize.	Name, contact details, passport information (if required), geo-location information, of Winner and Companions.

**3. SHARING & DISCLOSURE**

We will share and disclose Entrants’ personal information, including their Entries and related personal information with members of the Judging Panel to enable them to fulfill their roles in the Contest process as well as with third party service providers as described below.

We may share the Entrants’ (including Winner, Reserves and Companion/s, as the case maybe) personal information, including name, contact details, age range, with our partner, Philippines AirAsia, Inc (“**Partner**”), which will provide AirAsia travel credits to the final Winner, for use by the Winner and any accompanying Companion/s. Our Partner shall process such personal information in accordance with their [privacy policy](#).

Our service providers may be located inside or outside of the European Economic Area (“**EEA**”). Laws in these countries may differ from the laws applicable to your Country/Region of Residence. For example, personal information collected within the EEA may be transferred, stored, and processed outside of the EEA for the purposes described in this Supplementary Privacy Policy. Where we transfer, store, and process your personal information outside of the EEA we have ensured that appropriate safeguards are in place to ensure an adequate level of data protection. We will provide further information on the means used to ensure an adequate level of data protection upon request. **4. YOUR RIGHTS**

You have rights pursuant to applicable law. For more detail about these rights see Airbnb [Privacy Policy](#).

You may exercise any of the rights described in this section pursuant to applicable law in respect of your Entry, by communicating with us as set forth in the Airbnb [Privacy Policy](#).

**Data Retention and Erasure**

We will retain your personal information provided as part of the Contest, during the Contest process, and for post-Contest communications, in accordance with applicable laws. Unless you are selected as a Winner or a Reserve, we will delete your personal information provided in relation to the Contest within one (1) year from the closing of the Contest. If you no longer want us to process your personal information, you can request that we erase it by sending us an email explicitly indicating this request. Please note, if you have created an Airbnb account, your personal data connected to your account will be held in line with our retention periods as set out in the Airbnb [Privacy Policy](#).

Please note that if you request the erasure of your personal information :

- you will not be eligible to participate in the Contest;
- we may retain and use your personal information to the extent necessary to comply with applicable legal obligations; and
- in order to maintain the Site and secure it against accidental or malicious loss and destruction, residual copies of your personal information submitted as part of the Entry may not be removed from our backup systems for a limited period of time.

**5. CHANGES TO THIS SUPPLEMENTARY PRIVACY POLICY**

We reserve the right to modify this Supplementary Privacy Policy at any time in accordance with this provision. If we make changes, we will post the revised Supplementary Privacy Policy on the Site and update the “Last Updated” date at the top of this Policy. A revised Supplementary Privacy Policy will become immediately effective upon publication on the Site.

If you disagree with the revised Supplementary Privacy Policy, you must cease using the Site and, if you have already submitted your Entry form, please explicitly request to withdraw your Entry by sending an email to [liveandflyanywhereinph@gmail.com](mailto:liveandflyanywhereinph@gmail.com) with “privacy request” in the subject line, in which case you will not be included in the Contest.

If you do not withdraw your Entry and cease using the Site, the revised Supplementary Privacy Policy will apply to your continued access to and/or use of the Site and your participation in the Contest.
